### **Purpose**

User Tip: To locate the NCFS report most closely related to your legacy report (NCAS or Cognos), search [Ctl+F] for the name of the legacy report, or a portion of the legacy report name.

Furthermore, all receipts will get pulled in, whether they are applied, on-account, or unapplied.

The report will generate all invoices and credit memos created for orders and returns by LEAs using both state allotment and local funds for a given time period
