#### How to Get HELP

Follow these steps to access HELP for the current screen:

- 1. Press F to move the cursor to the ACTION field.
- **2.** Type HELP or ?.
- **3.** Press J.

The system displays the first page of HELP text available for the screen and positions the cursor at this message:

## Enter next page no. blank (next page) 'END' to terminate HELP.

- To view the next page of HELP text, press J.
- To view a specific page, type the page number and press J.
- To exit from HELP facility, type END and press J . The system then redisplays the screen you were working with.

# **Error Messages Originating from General Ledger**

FC 1122: COMPANY NOT FOUND ON GL OPEN YEARS FILE – The company is not valid on the General Ledger.

FC 1123: ACCOUNT NOT FOUND ON GL OPEN YEAR FILE – The account is not valid on the General Ledger.

FC 1137: CENTER NOT ON GL OPEN YEARS FILE – The company/account/center (accounting distribution) is not valid on the General Ledger.

## **Error Messages Originating from the Available Funds File (AFF)**

#### BC 217: INVALID COMBINATION OF ACCOUNTS FOR ADJUSTMENT

**TYPE** – You cannot use an illegal mixture of account types within the same budget transfer document.

**BC 219: DR TOTAL\_\_NOT=CR TOTAL** – The sum of the debits does not equal the sum of the credits within a data type 2 document.

**BC 224: ACCOUNT DISTRIBUTION INVALID** – The accounting distribution is not present on the AFF. (The distribution may actually be valid on the General Ledger but may not have updated the AFF yet.)

**BC 225: FUNDS NOT AVAILABLE FOR-\_\_\_/\_\_\_** - The accounting distribution for the transaction does not have funds available on the AFF.

BC 226: ACCOUNT DISTRIBUTION \_\_\_/\_\_\_/ NOT POSTABLE – The accounting distribution for the transaction is not a postable distribution for the AFF. (This usually occurs as a result of a multi-year indicator originating in the Purchasing Module.)

BC 227: ACCOUNT DISTRIBUTION \_\_\_/\_\_ INACTIVE – The accounting distribution for the current transaction is not an active accounting distribution on the General Ledger. (The status field does not equal 0.)

# BC 230: DR TOTAL=DR TOTAL BUT NOT=DOCUMENT TOTAL -

The sum of the debit detail lines amounts (equal to the sum of the credit detail line amounts) does not equal the document total entered on the document header for a data type 2 document.

**BC 231: DR/CR/ TOTAL\_\_NOT=DOCUMENT TOTAL** — The total of the document detail line amounts (computed regardless of sign) does not equal the document total entered on the document header within a data type 1 document.

BC 235: REQUEST OF KILL IS INVALID IF DETAIL LINES EXIST – A document cannot be killed before all of its detail lines have been deleted.
