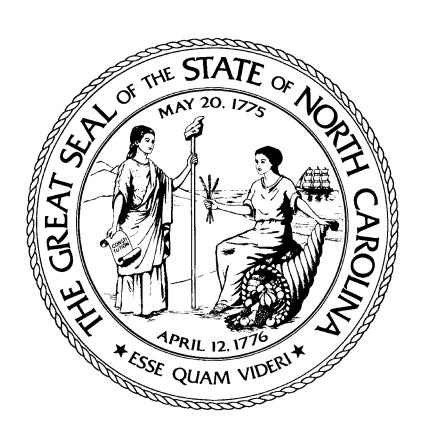

For the Period Ended June 30, 2000

The purpose of this report is to estimate total information technology expenditures within the State as required by Senate Bill 222 and House Bill 168. House Bill 168 defines information technology expenditures as "all expenses directly related to data processing and telecommunications, including expenses incurred for permanent, state-funded technical positions". Senate Bill 222 places an additional emphasis on reporting by specific information technology projects.

Identifying costs to specific information technology projects is not readily available in a statewide format within the central accounting, budgeting, and personnel systems at this time. The Office of the State Controller (OSC), Office of State Personnel (OSP), Office of State Budget and Management (OSBM), Office of State Planning (OSPL), and Office of Information Technology Services (ITS) have developed a statewide methodology for identifying costs to specific information technology projects. Beginning with fiscal year 2001, reports will incorporate project specific data as it becomes available in a standard format within the central management systems.

The basis for this cost estimate is the statewide chart of accounts and the personnel classification system. The primary sources of this data are the North Carolina Accounting System (NCAS) and the Personnel Management Information System (PMIS). This report covers the time period of July 1999 through June 2000 and includes all funding sources. At the time this report was generated, all agencies, except Housing Finance Authority, Department of Health and Human Services, and North Carolina State University had closed the June accounting period.

Under the NCAS chart of accounts, most information technology operational costs are identified through specific account codes. The primary exception is personnel related costs that are recorded within NCAS in aggregate without regard to the type of work performed by the position. To estimate the personnel costs associated to information technology positions, this report utilizes the class code structure within PMIS. The budgeted salary for all positions assigned an information technology specific class code is used to estimate each agency's personal services obligation for this fiscal year. However, universities operating their own payroll systems are not required to enter EPA position information into PMIS. Therefore, the personal services cost estimate may not include all IT positions established within the university system.

The other information technology operational accounts are summarized into the following categories:

Contracted Personal Services	Amounts paid to professional and personal services contractors to provide IT services.
Software	Includes both Software Maintenance and Software

	Software Maintenance: Contract expenses paid for the Software Maintenance Agreements (SMAs).
	Software Purchases/Development: Purchase of software from vendors such as Microsoft, IBM, etc. and includes amounts paid for custom developed software from outside vendors.
Hardware	Includes costs for the purchase, lease, rent, repair and maintenance of data processing and telecommunication equipment.
	<u>DP Equipment Repairs/Maintenance</u> : Expenses paid for the maintenance and repair of data processing equipment.
	<u>DP Equipment Rent/Leases</u> : Expenses paid to lease or rent data processing hardware such as PCs, mainframes, and computer peripherals.
	<u>DP Equipment Purchases</u> : Expenses paid to purchase data processing hardware such as PCs, mainframes, and computer peripherals.
	<u>Telecommunication Equipment Rent/Leases</u> : Expenses paid to lease or rent telecommunications hardware such as telephones, switching equipment, etc.
	<u>Telecommunications Equipment Purchases</u> : Expenses paid to purchase telecommunications hardware such as telephones, switching equipment, etc.
Data Processing Supplies	Purchases of data processing specific supplies such as tape labels, printer paper, special forms, etc.
Telecommunications and Networking Services	Amounts paid for telephone and data communications services from ITS as well as other outside vendors.
Mainframe Services	Expenses for data processing charges for mainframe or UNIX services paid to ITS or an outside vendor.

During the preparation of this report, OSC discovered several instances where agencies recorded information technology costs in an account other than those designated for information technology expenditures. Whenever possible, the report is adjusted to include the misclassified costs. OSC is working with the agencies to insure proper expense recording in the future.

This report includes several tables and schedules summarizing the information technology personnel and expense data. In response to user requests, several of the tables and schedules found in previous versions of this report have been replaced or revised. Each data table is described below:

Note 1: PMIS **budgeted** salary amounts plus calculated fringe benefit cost amounts are used to represent total salary cost, which means that the cost is overstated by the amount of lapsed salaries generated by vacant IT positions. This overstatement could be as much as \$36 million. OSC is calculating the cost of modifications to the State's Central Payroll System to allow reporting of actual IT personnel expenditures in the future.

Note 2: In the Software, Hardware, Supplies, Telecommunications/Networking, and Mainframe Services categories, the State Budget Manual allows agencies some flexibility to maintain their budget at a different level than they post expenditures.
